Approval of minutes from March 18, 2021 meeting motioned, seconded, and approved.

# Presentation by Mark Petersen (USGS) - Plans for the CEUS-WUS attenuation boundary in the 2023 NSHM Update.

- USGS is considering change to the Western US / CEUS attenuation boundary as part of their planned 2023 NSHM update.
- USGS held a workshop on April 28, 2021 which covered history of the CEUS/WUS boundary. Also discussed new data/research
  - o Evaluating kappa
  - o Improving regional ground motion attenuation boundaries and models
- Remaining tasks for the USGS include:
  - Review previous studies
  - o Review, process and plot data
  - Develop straw-man boundaries and perform sensitivity studies
  - Discuss results with the working group
  - Present draft models at the USGS 2023 NSHM Workshop.
- Mark Petersen, Oliver Boyd, and Will Levandowski provided comments about the CEUS-WUS
  attenuation boundary.

The options USGS are considering include:

- 1. Moving CP and RMZ into Western US.
- 2. Shift "upper cut" boundary further to the north.
- a. "hard boundary" for the seismicity catalog and use logic tree for the GMMs.
- b. New catalog for the Rocky Mountain and Colorado Plateau regions transition zone, no longer a hard boundary.
- 3. Logic tree approach with old and new boundaries.
- 2. The 2020 Building Resilient Infrastructure and Communities (BRIC) program and the Mitigation Project Proposal entitled "Colorado Earthquake Resilience Investigation Code Review & Rapid Visual Screening Pilot Study".

Update provided by Matt Arsenault (acting Colorado state hazard mitigation officer) and Patricia Gavelda. Steve Boand has left his position as of April 2021. CO is waiting for incoming information from FEMA and there are no updates on the status of this project. New information might be available in late summer (August?) 2021. State and local hazard mitigation plans are prioritized over the CEHMC proposal.

- 3. Critical Facilities Inventory Subcommittee Keith Porter.
  - Keith is not on the call postponed discussion.
- 4. The Seismic Committee of the Structural Engineers Association of Colorado New Position Statement on the Seismic Safety of New Colorado Schools Rob Jackson.
